

**ADAMS COUNTY, COLORADO  
SERVICE AGREEMENT  
AMENDMENT THREE**

THIS AMENDMENT TO THE SERVICE AGREEMENT ("Amendment Three") is entered into this 24 day of March, 2017, by and between the Board of County Commissioners of Adams County, Colorado, located at 4430 South Adams County Parkway, Brighton, CO 80601, hereinafter referred to as the "County," and Armored Knights Inc., located at 375 Yuma Street, Denver, Colorado 80204 hereinafter referred to as the "Contractor." The County and the Contractor may be collectively referred to herein as the "Parties".

**RECITALS**

WHEREAS, on March 20, 2015, the County entered into Service Agreement 2015-416 with Armored Knights Inc., to provide Armored Car Services; and,

WHEREAS, on February 11, 2016 the County and the Contractor amended the Agreement revising the location schedule and adding services; and,

WHEREAS, the County and the Contractor mutually desire to extend the Agreement beginning January 1, 2017 through April 30, 2017.

NOW, THEREFORE, for the consideration set forth herein, the sufficiency of which is mutually acknowledged by the Parties, the County and the Contractor agree as follows:

1. The term of the Agreement is extended for four months, beginning January 1, 2017 through April 30, 2017.
2. The pricing structure set forth in Amendment Two shall remain in effect for the duration of this Amendment Three.
3. The Service Agreement and Amendments Two and Three contain the entire understanding of the parties hereto and neither it, nor the rights and obligations hereunder, may be changed, modified, or waived except by an instrument in writing that is signed by both parties. Any terms, conditions, or provisions of the Service Agreement that are not amended or modified by Amendments Two and Three shall remain in full force and effect. In the event of any conflicts between the terms, conditions, or provisions of the Service Agreement the terms, conditions, and provisions of Amendments Two and Three shall prevail.
4. The Recitals contained in Amendments Two and Three are incorporated into the body hereof, and accurately reflect the intent and agreement of the parties.
5. Amendment Three may be executed in multiple counterparts, each of which shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.
6. Nothing expressed or implied in Amendment Two and Three is intended or shall be construed to confer upon or to give to, any person other than the parties, any right, remedy, or claim under or by reason of Amendments Two and Three or any terms, conditions, or provisions hereof. All terms, conditions, and provisions in Amendment Two and Three by and on behalf of the County and the Contractor shall be for the sole and exclusive benefit of the County and the Contractor.

7. If any provision of Amendments Two and Three is determined to be unenforceable or invalid for any reason, the remainder of Amendment Three shall remain in effect, unless otherwise terminated in accordance with the terms contained in the Service Agreement.
8. Each party represents and warrants that it has the power and ability to enter into Amendments Two and Three, to grant the rights granted herein, and to perform the duties and obligations herein described.
