SERVICE AGREEMENT
ADDENDUM THREE

THIS ADDENDUM TO THE SERVICE AGREEMENT ("Addendum") is entered into this 7th day of January, 2014, by and between the Board of County Commissioners of Adams County, Colorado, located at 4430 South Adams County Parkway, Brighton, CO 80601, hereinafter referred to as the "County," and **Laboratory Corporation of America Holdings (LabCorp)** located at 1440 York Court, Burlington, NC 27215, hereinafter referred to as the "Contractor." The County and the Contractor may be collectively referred to herein as the "Parties".

RECITALS

WHEREAS, on November 28, 2011 the County entered into a Service Agreements under Agreement #IFB 2011.133 and Addendum Two #2012.273-Option Year One with **Laboratory Corporation of America Holdings (LabCorp)**, to provide a Laboratory Testing Services, and,

WHEREAS, the County and the Contractor mutually desire to extend the last option year of the Service Agreement effective November 28, 2013, pursuant to **Section 2 Extension Option**; and,

NOW, THEREFORE, for the consideration set forth herein, the sufficiency of which is mutually acknowledged by the parties, the County and the Contractor agree as follows:

1. This Addendum is effective November 28, 2013.
2. The County shall pay the Contractor for the work furnished under this Addendum in accordance with **Section 3 Payment and Price Schedule Exhibit A of Service Agreement RFP2011.133** for a sum not to exceed thirty-six thousand, seven hundred ninety-six dollars and sixty cents (\$36,796.60).
3. The term of the Service Agreement is extended for one (1) additional year effective through November 28, 2014.
4. The Service Agreement, Addendum One, Addendum Two and **Addendum Three** contain the entire understanding of the parties hereto and neither it, nor the rights and obligations hereunder, may be changed, modified, or waived except by an instrument in writing that is signed by both parties. Any terms, conditions, or provisions of the Service Agreement, Addendum One and Addendum Two that are not amended or modified by Addendum Three shall remain in full force and effect. In the event of any conflicts between the terms, conditions, or provisions of the Service Agreement, Addendum One, Addendum Two, and Addendum Three, the terms, conditions, and provisions of Addendum Three shall prevail.
5. The Recitals contained in Addendum Three are incorporated into the body hereof, and accurately reflect the intent and agreement of the parties.
6. Addendum Three may be executed in multiple counterparts, each of which shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

7. Nothing expressed or implied in Addendum Three is intended or shall be construed to confer upon or to give to, any person other than the parties, any right, remedy, or claim under or by reason of Addendum Three or any terms, conditions, or provisions hereof. All terms, conditions, and provisions in Addendum Three by and on behalf of the County and the Contractor shall be for the sole and exclusive benefit of the County and the Contractor.
8. If any provision of Addendum Three is determined to be unenforceable or invalid for any reason, the remainder of Addendum Three shall remain in effect, unless otherwise terminated in accordance with the terms contained in the Service Agreement.
9. Each party represents and warrants that it has the power and ability to enter into Addendum Three, to grant the rights granted herein, and to perform the duties and obligations herein described.
