

ADAMS COUNTY, COLORADO
SERVICE AGREEMENT
SECOND ADDENDUM

THIS ADDENDUM TO THE SERVICE AGREEMENT ("Addendum") is entered into this 17th day of August, 2015, by and between the Board of County Commissioners of Adams County, Colorado, located at 4430 South Adams County Parkway, Brighton, CO 80601, hereinafter referred to as the "County," and **North Metro Community Services (NMCS)**, located at 1001 West 124th Avenue, Westminster, Colorado 80234, hereinafter referred to as the "Contractor." The County and the Contractor may be collectively referred to herein as the "Parties".

RECITALS

WHEREAS, on January 23, 2013, the County entered into a Service Agreement under Agreement #RFP 2013.145 with **North Metro Community Services (NMCS)** to provide case management services to transition developmentally disabled youth from the Adams County Human Services system to their system; and,

WHEREAS, the term of the agreement expired on June 30, 2014; and,

WHEREAS, the County and the Contractor amended the Service Agreement to renew for one additional year effective July 1, 2014 through June 30, 2015; and,

WHEREAS, the County and the Contractor mutually desire to extend the Service Agreement for an addition year beginning July 1, 2015 through June 30, 2016.

NOW, THEREFORE, for the consideration set forth herein, the sufficiency of which is mutually acknowledged by the Parties, the County and the Contractor agree as follows:

1. The County shall pay the Contractor for the work furnished under this Second Addendum in accordance with **Section V, Payment and Fee Schedule of Service Agreement RFP 2012.145** for a sum not exceed thirty-eight thousand, four hundred-seventy five dollars and no cents (38,475.00).
2. The term of the Service Agreement is extended for one (1) additional year effective through June 30, 2016.
3. The Service Agreement and the Second Addendum contain the entire understanding of the parties hereto and neither it, nor the rights and obligations hereunder, may be changed, modified, or waived except by an instrument in writing that is signed by both parties. Any terms, conditions, or provisions of the Service Agreement that are not amended or modified by the Second Addendum shall remain in full force and effect. In the event of any conflicts between the terms, conditions, or provisions of the Service Agreement, the terms, conditions, and provisions of the Second Addendum shall prevail.
4. The Recitals contained in the Second Addendum are incorporated into the body hereof, and accurately reflect the intent and agreement of the parties.

5. The Second Addendum may be executed in multiple counterparts, each of which shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.
6. Nothing expressed or implied in the Second Addendum is intended or shall be construed to confer upon or to give to, any person other than the parties, any right, remedy, or claim under or by reason of Addendum One or any terms, conditions, or provisions hereof. All terms, conditions, and provisions in the Second Addendum by and on behalf of the County and the Contractor shall be for the sole and exclusive benefit of the County and the Contractor.
7. If any provision of the Second Addendum is determined to be unenforceable or invalid for any reason, the remainder of the Second Addendum shall remain in effect, unless otherwise terminated in accordance with the terms contained in the Service Agreement.
8. Each party represents and warrants that it has the power and ability to enter into the Second Addendum, to grant the rights granted herein, and to perform the duties and obligations herein described.



Exhibit "A"

PURPOSE – SCOPE OF WORK

To provide early identification and a smooth transition for developmentally disabled youth from Adams County Human Services Department (ACHSD) to North Metro Community Services (NMCS). Services will include:

- Two part-time or one full time case manager (s) to help transition at least six youth to the DD system from child welfare.
- Completion of annual individualized plans for each client.
- Coordination with ACHSD for foster care reviews.
- Attendance of court hearings as requested by ACHSD, when appropriate.
- Maintain ACHSD clients on the NMCS waiting list.
- Identification of and assistance with accessing community resources for each client.
- Assistance with recruitment and obtaining placements for challenging clients by identification of homes that meet NMCS standards.

ANTICIPATED OUTCOMES

As a result of the goods and/or services provided by the Contractor under this Agreement, the following outcomes are anticipated:

- Individualized plans for mutual clients will be developed.
- Program eligibility will be accurately documented.
- Community resources will be identified and explored for each client.
- Increased placement options for clients.
- Earlier identification and transition into NMCS programs.
