

STATEMENT OF PURPOSE

TO THE BOARD OF COUNTY COMMISSIONERS OF ADAMS COUNTY, COLORADO

Comes Now the Crestview Water and Sanitation District ("District") pursuant to Title 32-1-208 C.R.S. 1973, as amended, and submits the following Statement of Purpose consisting of this Statement of Purpose and the attached exhibits or documents which shall collectively constitute the "Statement of Purpose" of the Crestview Water and Sanitation District, a quasi-municipal corporation organized and existing under and by virtue of the laws of the State of Colorado.

RECITAL

The Crestview Water and Sanitation District formerly the Baker Metropolitan Water and Sanitation District was established by Order and Decree of the District Court of Adams County, Colorado, records June 30, 1949, in Book 61 pages 30-35 respectively. After approval of its formation by the electors of the proposed District at an election held on June 25, 1949.

Pursuant to the request of the District, the District Court in and for Adams County, Colorado entered an Order on June 7, 1972, changing the district from Baker Metropolitan Water and Sanitation District to Crestview Water and Sanitation District.

1. PURPOSE FOR WHICH THE DISTRICT WAS ORGANIZED

(a) The District was organized to purchase, acquire, own, lease and otherwise utilize surface and ground water rights to enable the District to furnish potable water for its users within the District or under contract with the District for residential, domestic, municipal, manufacturing, industrial, commercial, recreation, irrigation and fire protection and such other purposes authorized by the Board of Directors of the District and authorized by Title 32, Special District Act, C.R.S. 1973, as amended.

(b) The District was also organized to treat and furnish treatment for residential, domestic, industrial, manufacturing, and commercial waste water. In addition to providing treatment for such other waste water through its collection system and treatment plant or plants as may be authorized by the Board of Directors of the District and authorized by Title 32, Special Districts Act, C.R.S. 1973, as amended.

2. FACILITIES PROVIDED BY THE DISTRICT

(a) WATER FACILITIES. Water for the aforementioned purposes is presently obtained from decreed - adjudicated surface flow rights from Clear Creek and Ralston Creek. In addition to water obtained from 3 deep non tributary adjudicated wells, pursuant to State of Colorado requirements. Additionally, approximately 13 percent of the District's total annual water requirements is furnished by the Denver Water Department under a commingling Distributor's Contract No. 66. Such water is all distributed by the District's existing transmission mains, distribution system, treatment plant and booster pumping facilities. More clearly shown and described in exhibit "A" attached hereto and incorporated herein by reference.

(b) The District collects wastewater through a series of sanitary sewage collection system lines and lift station as shown in exhibit "B" attached hereto and incorporated herein by reference. All wastewater collected within the District's system is discharged into the Metropolitan Denver Sewage Disposal District No. I, Clear Creek Interceptor sewer. Secondary treatment is provided by MDSDD pursuant to the terms and conditions of a perpetual contract between Crestview and Metro Denver entered into in 1961. All wastewater treated by MDSDD is in full compliance with the secondary treatment standards established by the Colorado Department of Health and the Environmental Protection Agency.

3. FACILITIES TO BE FURNISHED BY THE DISTRICT

(a) WATER FACILITIES. The District will continue to develop distribution system facilities and obtain adequate potable water supplies for existing and additional users residing within the boundaries of the District, or contracting with the District, in compliance with the District's current and long range projections for service.

(b) WASTEWATER FACILITIES. The District will continue to develop collection system facilities required to adequately provide sanitary sewer service for existing and additional users residing within the boundaries of the District or contracting with the District, in compliance with the District's, current and long range projections for service.


4. AREA SERVED OR TO BE SERVED


