# **Development Process**

### • CIP Portal opened for requests in January 2020

- Two Capital Projects Roundtables were hosted in February to help departments develop more complete capital project requests
- Projects vetted by subject matter experts from Facilities, Building Safety, Land Use, ITi, and Budget prior to scoring by Committee members
- 116 projects were submitted and reviewed by the CIP Committee, with estimated expenditures as follows:

# **Evaluation and Scoring**

### • Scoring Criteria

- 1. Board of County Commissioners (BoCC) Adopted Strategic Vision and/or Priorities
- 2. Public health, safety, or regulatory threat
- 3. Infrastructure investment/protection
- 4. Impact on county operational finances/revenue generation
- 5. Leverages outside funding
- 6. Environmental sustainability
- 7. Encouragement of economic development
- 8. Neighborhood revitalization/community needs
- 9. Ties in to other projects/organizations
- 10. Improves and/or increases the level of service provided by the county
- 11. Implementation risk
- Departments gave presentations about projects in June 2020
- Committee members applied the scoring criteria to projects based on the project submission in the CIP Portal and the presentations given by departments



# **Funding Constraints**

- Sales and Property taxes are the primary source of revenue for capital projects
  - Economic uncertainty related to COVID-19 lead the committee to be more conservative in level or project recommendations for 2021
- Several existing projects currently being cash financed
  - Animal Shelter
  - Fleet & Public Works Building
  - Government Center Reprogramming



## Recommendations

- Projects were recommended based on scoring rank, funding availability, and human capacity to complete a project
  - Projects were ranked by total score, but special attention was paid to Criteria 11: Implementation risk
- Minimum total score and implementation risk scores were set based on statistical analysis
- Projects were discussed at length, and a final list of recommendations with the following expenditures was approved by the committee:



# **Proposed Design Budget & Schedule**

### • Original Concept: \$3,500,000 Total Project

- Work focused primarily on "pinch points" from Program: Cooler, Freezer, Autopsy Suite
- Minimal changes to existing administrative offices, use most space "as-is"
- Still consider a future facility in 2026 to 2028
- Current Design: \$9,100,000 Total Project (included in 2021 Proposed CIP Budget)
  - Includes all "pinch points" from Program: Cooler, Freezer, Autopsy Suite
  - Includes Administrative offices, work flow efficiencies, improved workspaces and amenities
  - Includes dedicated Probation function / separated for efficiency
  - Replacement of a portion of aging MEP systems
- Proposed Schedule (tentative subject to change):
  - Design: September 2020 through Q2 2021
  - Construction: Q2 or 3 2021 through Q2 2022
