1. **Call Meeting to Order/ Introductions** – Glenn Grove called the meeting to order followed by introductions by members that were present.
  2. **Approval of February Meeting Minutes** – Chris motioned to approve February meeting, Wayne second the motion.
  3. **Legislative / Regulatory Updates**
    - Senate Bill 19-032 Haz Mat Transportation Routing - Discussed this bill which concerns the routing of hazardous materials being transported on the roadways of the state. The bill authorizes a public highway authority or a governmental partners to apply to the Colorado State Patrol for a new or modified hazardous materials route designation for a road or highway that is directly or indirectly maintains.
    - Senate Bill 19-181 Oil & Gas Operations – This bill enhances local governments’ ability to protect public health, safety, and welfare, and the environment by clarifying, reinforcing, and establishing their regulatory authority over the surface impacts of oil & gas development.
    - Final Rule on High-Hazard Trains – PHMSA in coordination with Federal Railroad Admin. Published a final rule on high- hazard trains. The final rule requires rail carriers that operate high-hazard trains to provide notifications to each applicable SERC or TERC upon request.
  4. **Partner Updates**
    - Westminster OEM (Greg Moser) – Would like to know how they can request notifications from the railroads when they have high-hazard trains coming through their jurisdiction?
    - EPA Region 8 (Breann Bockstahler): - Advised that both the Final Rule on High-Hazard Trains and the American Water Infrastructure Act will be discussed at the national CERC Conference. Hoping procedures will be forthcoming on notifications.

  - April: 1 - sewage spill 12,500 gal to ground by ditch that flows into the South Platte.
