PURPOSE OF ITEM: Present the Open Space Advisory Board's recommendations to the Board of County Commissioners to understand whether there is concurrence prior to presenting awards in public hearing.
STAFF RECOMMENDATION: That the Board of County Commissioners accepts the Open Space Advisory Board's recommendations for funding

# **BACKGROUND:**

On February 1, 2016, the Open Space Program received seventeen grant applications, including eleven passive grant applications, three active grant applications, and three mini-grant applications. The total amount requested was \$5,470,330 which included \$4,834,070 for passive projects, \$627,874 for active projects, and \$8,386 for mini-grants. The total amount available for distribution was \$6,070,399.14.

The Open Space Advisory Board (OSAB) recommended full funding of all seventeen applications for a total of \$5,470,330.

If the Board of County Commissioners follows the OSAB's recommendations, there will be a balance of \$600,069.14 available. The recommended funding decreases the level of overall active funding from 28.93% to 28.03%.

Detailed information about each grant and the OSAB's recommendations are below. The projects are listed according to their ranking, with mini-grants listed first.

# Mini Grant: Adams 12 STEM Launch Niver Nature Heritage Trail Collaboration Project-City of Thornton

**Project Summary:** This project involves students from the Adams 12 STEM Launch school for the construction and installation of bird and bat houses in the natural areas, adding decoratively painted trash cans, and panting the bridge wing walls along the trail. The project site is located at 9402 Inca Court.

Grant Request: 69.9% of the total project costs, up to \$711

# Mini Grant: Clear Creek Valley Park Pollinator Habitat Project-Hyland Hills Park & Recreation District (Sponsored by City of Westminster)

**Project Summary:** This project will partner with the Butterfly Pavilion to create a Pollinator Garden to the west of the Clear Creek Valley Park community gardens. The garden will include raised bed lots for residents to grow food or flowers. Clear Creek Valley Park is located at 5902 Tennyson Street.

# Mini Grant: Lake Appreciation Day 2016- Barr Lake State Park (Sponsored by Adams County)

**Project Summary:** The purpose of this project is to bring public awareness to water quality and issues through the participation of 250 volunteers performing shoreline cleanup, eradicating noxious weeds, and staining boardwalks. The event is followed by lunch and educational activities for the volunteers. Barr Lake State Park is located at 13401 Piccadilly Rd.

Grant Request: 23.9% of the total project costs, up to \$2,675

# Metzger Farm Farmstead Improvements Project- City of Westminster

**Project Summary:** This project involves the final step in the preservation of the farmstead at Metzger Farm. This phase includes building stabilization and interpretive signage to allow future public access. Metzger Farm is located at the northeast corner of 120<sup>th</sup> Avenue and Federal Boulevard.

Type: Passive

Grant Request: 58% of the total project costs, up to \$379,751

Previous Grant Request: Yes No

# **OSAB** Comments:

- If possible, I would like to see the common carp removed from the ponds, since they tend to inhibit native aquatic plant growth.
- Metzger Farm House Improvements are part of an overall excellent project with great regional appeal and preservation effort. I commend the trail connectivity. I encourage trail construction with soft surface walking/running space next to or near concrete construction. I think these trails offer more choices to a wider range of trail users.
- If the buildings continue to deteriorate the cost of repair will escalate, probably saves money to attend to now.
- Completion of the farm will provide opportunity for a history lesson as well as life on a farm.
- Prairie dogs are present and are not welcome on a working farm, so some wildlife will be eliminated.
- I think the farm will explain its history to loads of school children and many adults will remember their years on farms. Preservation of this farm is a great feat.
- It is important to stabilize the farm buildings as they are part of the area's history.

# Big Dry Creek Trail Upgrade Project- City of Westminster

**Project Summary:** This project will upgrade approximately 1.3 miles of the Big Dry Creek Trail between 112<sup>th</sup> Avenue and 120<sup>th</sup> Avenue. The trail is currently 8' wide crusher fines and will be upgraded to 10'

wide concrete with 4' aggregate for snow plowing and increased safety of trail users. Big Dry Creek Trail is located between 112 <sup>th</sup> - 120 <sup>th</sup> Avenues and Federal and Sheridan Boulevards.  Type: Passive
Grant Request: 65.4% of the total project costs, up to \$300,000

OSAB Comments:
<ul> <li>This is an excellent project to improve connecting trails along the Big Dry Creek, a major water way through Adams County. I especially commend the soft and hard surface trail construction combo. I think that appeals to a wider variety of trail users.</li> </ul>
<ul> <li>As a project ranked second priority by the applicant, I would recommend funding if funds allow.</li> <li>This upgrade will allow all season use of the trail. Bikes, wheelchairs along with walkers and runners, it will benefit the community.</li> </ul>
Bromley- Hishinuma Farm Interiors Project- City of Brighton Project Summary: This project will rehabilitate the interiors of the Migrant Workers House and the first and second floors of the Farm Main House. The project includes architectural design and rehabilitation of the floors, walls, trim, stairs, windows, and doors of both houses. The Bromley-Hishinuma Farm is located at 1594 East Bromley Lane.

<ul> <li>What consideration has been given to how people with mobility limitations access and use the property inside and around the various buildings?</li> </ul>
- Landscaping and agricultural use of farm land soils may attract bird wildlife.
- The Bromley-Hishinuma Farm House project, when completed and opened to the public, will be a historical asset to the Brighton community. The farm acreage offers a variety of options for 21st Century small acre high value farming activities that will be a complement to the B-H Farm
<ul> <li>House and other farm buildings.</li> <li>Brighton has a commendable historic preservation area that should be a showcase for others to pattern after.</li> </ul>
- The historic buildings need to be rehabilitated so they will be preserved for the purpose of giving a history of the Bromley Hishinuma Farm and the farming community.
CFRT(Colorado Front Range Trail)- Veterans Park Missing Trail Link- City of Brighton
Project Summary: This project will create a safe new access for trail users adjacent to Highway 7 and
through Veterans Park. It will connect Downtown Brighton through the Adams County Fairgrounds to
Denver going south and in the future will connect to Longmont and Fort Collins going north. It will create
1,775 linear feet of 10' wide trail, a 50 foot bridge, 540 feet of trail over a stormwater pipe, engineering
and design, as well as revegetation. Veterans Park is located at 405 West Bridge Street.

Grant Request: 60% of the total project costs, up to \$226,115

**OSAB** Comments:

- The Veterans Park trail connection to CFRT and downtown Brighton is a very important linkage to complete. The area also has good wildlife habitat along the South Platte into the Morgan Smith Nature Area. I encourage the City to consider using a combination of soft and hard surfaces in trail construction. The soft surface trails are easier on the body of runners and walkers.

- Trail safety along Hwy7 into and out of Brighton, in my opinion, is a growing concern. The trail project will be safer. I continue to have questions about safely connecting downtown Brighton to the west side of Hwy 85 for people to access the CFRT. Has the City considered working with CDOT to have slower HWY 85 speeds to 55mph between CO Rd 2 and 144th Ave.? Also will there be a stoplight installed at HWY 7 & Miller Ave to slow traffic entering into the round abouts? Has another pedestrian bridge been considered or some pedestrian crossing with signal lights across HWY 85?
- There is a need to complete this important trail segment.
- This trail will provide a safe new access for trail user adjacent to Highway 7 and through Veterans Park.

# Kiowa Creek Trail Engineering Phase II- Town of Bennett

**Project Summary:** The Town of Bennett is requesting funding for the Colorado Department of Transportation and Federal Highway Administration approvals to construct the Interstate 70 segment of the Kiowa Creek Trail. The trail is located at I-70 and Kiowa Creek.

Type: Passive

Grant Request: 21.3% of the total project costs, up to \$17,000

**OSAB** Comments:

- This is a needed project I70 cuts from the area and makes dangerous crossings.
- A trail along Kiowa Creek will add enrichment for the people of Bennett. Before the trail can be built a Categorical Exclusion is required regarding potential environmental, cultural and related impacts.

# Sand Creek Park Improvements Project- City of Aurora

**Project Summary:** The City of Aurora plans to construct a shelter and nature based playground as well as walkways to improve circulation at the Sand Creek Park. Sand Creek Park is located at 2700 North Peoria Street.

Type: Passive

Grant Request: 49.4% of the total project costs, up to \$325,000

# **OSAB** Comments:

- This project is designed to keep some of the play area away from Sand Creek waterway where more wildlife is likely to be.
- RTD will fund some of the western parking lot but no definite number is known
- Creative play structures for younger aged children lends itself well to the Sand Creek corridor. Light rail users and others will have shelter and playground once Light Rail opens in the area.
- The change of placement of the light rail has been a challenge for Sand Creek Park and Aurora has met the change with ingenuity.
- The Sand Creek Park will have the light rail. A small shelter and playground will be a benefit to the people using the light rail and the community.

### Pedestrian Underpass at York Street on Clear Creek- Adams County

**Project Summary:** Adams County plans to construct a pedestrian underpass below Highway 224 along York Street in order to create greater connectivity to the Clear Creek Regional Trail and provide a safer route for trail users. The project site is located at York Street and Clear Creek.

Type: Passive

Grant Request: 50% of the total project costs, up to \$950,000

#### **OSAB** Comments:

- There is a high need for a safe passage way for pedestrians and bikers to access the Clear Creek Regional Trail
- Safety across a busy CO highway is being addressed. When possible I think a combination of soft and hard surface trail constructions would be a better choice for a wider variety of trail users.
- It is clear pedestrians face danger on York Street with heavy traffic and no sidewalks. This is a needed project.
- Because of the traffic along Highway 224 it is dangerous for people to cross over to the trail on the south. The underpass will provide safe passage.

# Clear Creek Trail Replacement- Adams County

**Project Summary:** Adams County is requesting funding for the repair and upgrade to a section of the Clear Creek Trail that runs along the Lower Clear Creek and Colorado Agricultural ditches. This includes 900 feet of trail replacement, stabilization of the ditch bank and a 2' shoulder added to the trail. The project site is located along the Clear Creek Trail between the LCC Diversion Dam & Kalcevic Gulch.

Type: Passive

Grant Request: 50% of the total project costs, up to \$220,500

#### OSAB Comments:

- With the development that is taking place in this area, this trail needs to be repaired in a timely manner.
- This is a needed trail repair that will include soft and hard surface trail construction from which a wide range of trail users can benefit.
- The Clear Creek Trail is in need of repair near 68th and Huron. Without repair there is a possibility the trail will be unusable.
- When concrete starts to heave and water is undermining it, replacement should be as soon as possible before it continues to degrade.

# Martinez Property Acquisition- City of Commerce City

**Project Summary:** The City of Commerce City is requesting support to fund the acquisition of a residential lot adjacent to the Veterans Memorial Park and the Commerce City Recreation Center. The project also includes demolishing the existing house, grading, and installation of irrigation and sod on the site. The property is located at 6023 Forest Drive.

Type: Active

Grant Request: 49.9% of the total project costs, up to \$90,000

# OSAB Comments:

- A piece of property to expand the park space has become available for purchase. With purchase of the property the recreation center can expand parking or other needs as identified by park users.
- The property is surrounded by the park. Purchasing this property will unify the park.

# Moorhead Splash Pad- City of Aurora

**Project Summary:** The City of Aurora is requesting funding towards the construction of an aquatics spray ground as part of the renovations to the Moorhead Recreation Center. Providing a splash pad feature for younger children will allow the recreation center to serve a wider range of users within the community. The Moorhead Recreation Center is located at 2390 North Havana Street.

Type: Active

Grant Request: 2% of the total project costs, up to \$160,000

Previous Grant Request: Yes No OSAB Recommendation: Full funding, \$160,000

OSAB Vote: Motion for full funding passed 5-0

#### **OSAB** Comments:

- This is a vital piece of recreation for this neighborhood. It is an area that needs outlets for the children.
- Development for housing is hemmed in and the children need a place to gather.
- The pool area that young children and families use will be removed in the building of the new recreation center. A splash pad area for toddlers and young children is needed for this age group.
- A safe splash pool for children is important for their safety.

# Construction of FasTracks Neighborhood Connections & Pedestrian Underpass Project- City of Thornton

**Project Summary:** This project funds construction of neighborhood connections to four North Metro FasTracks stations scheduled to open in 2018, the purchase of five right-of-way parcels to accommodate the connections, as well as the design and construction of a pedestrian and bicycle underpass at the 88<sup>th</sup> Avenue FasTracks station. These connections will improve safety issues and help integrate the stations within the neighborhoods. These sites are located throughout the City of Thornton.

Type: Passive

Grant Request: 50% of the total project costs, up to \$1,514,139

Previous Grant Request: Yes No

OSAB Recommendation: Full funding, \$1,514,139 OSAB Vote: Motion for full funding passed 5-0

#### OSAB Comments:

- As traffic becomes more dense the need for underpasses becomes more vital.
- This project provides a safer means of trail connections for people to access Light Rail service when this North Metro FasTracks station opens in 2018. While not so applicable in this project, I recommend combining soft and hard surfaces into trail construction when possible for a wider variety of trail users.
- The neighborhood connections to FasTracks will provide a safe entrance to the station

# Engaging Adams County Residents/ Visitors in Open Spaces with Environmental Education-Bird Conservancy of the Rockies (Sponsored by Adams County)

**Project Summary:** This grant will provide funding to support environmental education and programming through educational staff, volunteer coordination, and scholarships for program participants. Bird Conservancy of the Rockies is located at 14500 Lark Bunting Lane.

*Type:* Passive

Grant Request: 39.7% of the total project costs, up to \$190,854

Previous Grant Request: Yes No

OSAB Recommendation: Full funding, \$190,854 OSAB Vote: Motion for full funding passed 5-0

### OSAB Comments:

- This project involves connecting people to the land through trained staff and volunteers on the natural resource and cultural/historic resources in parks and open space locations.
- Bird Conservancy of the Rockies continues its high quality environmental education services to engage a variety of people in the natural world around them; to help instruct students on CO Dept of Education's environmental education curriculum; to offer financial support to people that helps them get out into the natural world and experience a world where humans aren't necessarily the dominant species.
- At some point in time the open space sales tax should not be expected to continue paying for salaries for this program. I feel they should look to bird seed companies and other mentors of birds.
- Scholarship money will provide an opportunity for children to experience education at the Bird Conservancy. Other money will enrich programs and provide training for volunteers.

# Woodglen Brookshire Community Park Restrooms Project- City of Thornton

**Project Summary:** The City of Thornton is requesting support for the design and construction of restrooms at the Woodglen Brookshire Park. The project includes the tap, testing, water line, sewer line, electrical, plumbing, landscape restoration, and associated items. Woodglen Brookshire Park is located at 11730 Saint Paul Street.

Type: Active

Grant Request: 60% of the total project costs, up to \$377,874

Previous Grant Request: Yes No

OSAB Recommendation: Full funding, \$377,874 OSAB Vote: Motion for full funding passed 5-0

#### **OSAB** Comments:

- This is a much needed bathroom facility that park users will appreciate.
- Restrooms are expensive and if there is enough money to fund construction I would approve it, but other active needs would be a priority over restrooms.
- Citizens have requested flush toilets at the community level parks. I agree this is a necessary addition for the users of the park.

# <u>Westgate Community Environmental Campus- Construction Phase I- Westgate Community School (Sponsored by City of Thornton)</u>

**Project Summary:** This grant request involves site preparation, a public pavilion, grassy open space area, shade trees, shade structures, sloped embankments, a social plaza with benches and tables, a grassy amphitheater with terraced boulders, landscape and irrigation. The project also includes the addition of a K-5 playground funded by GOCO. Westgate Community School is located at 12500 Washington Street. **Type:** Passive

Grant Request: 62.8% of the total project costs, up to \$435,711

Previous Grant Request: Yes No

OSAB Recommendation: Full funding, \$435,711 OSAB Vote: Motion for full funding passed 5-0

#### OSAB Comments:

- The project over time has been better planned and described. It is an ambitious project that has much potential.
- I am concerned as phase one is for \$435,711 and I think I saw that there would be future development needed to finish the 10 acres. This is expensive for only partial access to the public.
- I would not support a long term need for funding if this is the beginning of that thought process.
- The Westgate School will be the primary user of the facilities. It is my hope the community also will use the facilities.
- Due to the number of times this grant request has come before us, its merits, the GOCO grants, and the needs of the greater community, it needs to be funded now.
- I would recommend having inviting signs placed in many locations, inviting the community in when school is not in session.
- I lowered my support because of the grant request being high compared to the matching funds, as I prefer less than a 60% request.

# **Adams County Open Space Advisory Board**

Meeting Minutes April 27, 2016 5:30 p.m. Adams County Regional Park

#### **Introductions**

Ms. Merkel called the meeting to order at 5:30 PM. The meeting began with the Pledge of Allegiance. The Open Space Advisory Board members and County staff introduced themselves.

# Approval of Meeting Minutes from February 20, 2016 and February 24, 2016

A motion was made by <u>Ms. Dowling</u> and seconded by <u>Ms. Dunn</u> to *Approve the minutes* for the February 20, 2016 and February 24, 2016 meetings. The motion passed unanimously.

# **Update on Fund Balance**

Ms. Petersen informed the Board that there is \$6,070,399.14 available to award and \$5,470,330 is being requested in the current grant cycle.

Ms. Petersen then asked Tracy Young and Kendall Koca from the City of Aurora to speak to the OSAB about an update to the Moorhead Splash Pad grant application. They explained to the OSAB that initially the project had been split into two phases. Phase I would be the renovation to the recreation center with some improvements to the pool, and phase II would be the pool enclosure. When bids came in so favorably, at about \$2 million less, Council decided to do both phases together. As a result of that, they want to still incorporate the spray features into the enclosed area in order to appeal to all user groups and would like their application to remain.

### **Question/Answer Period**

Ms. Dunn asked the City of Aurora if based on the update to their project, if the pool would then be a year round amenity. They responded that yes, that would be accessible year round at the center.

Ms. Rudden asked if the splash pad being inside the enclosure would create moisture issues. Ms. Koca replied that a new ventilation system would be installed as part of the renovation to account for the moisture.

Mr. Hickel asked what Westgate was planning in order to encourage residents to utilize the area being designed. Ms. Collins from the Westgate School explained that the students had surveys the nearby residents and planned to invite them to grand opening, and were visiting the local schools and offering for them to use the outdoor area for education as well. Mr. Hickel then asked about signage being posted to invite the community in. Ms. Collins stated they would have signs to welcome the community and were also working with 4H to create awareness of the school.

Ms. Rudden asked about vandalism being an issue for the Westgate School. Ms. Collins explained that they have been lucky to not experience those issues yet. They also planned to install cameras to monitor the area and felt that the best way to decrease that possibility was to have the area widely utilized. With more use and visitation, vandals will be deterred from the area. With the location also so close to Washington and that traffic it also helps the property be more visible.

# **Matters from the Parks Staff**

Ms. McDowell indicated the balance after the current funding recommendation is approximately \$600,000 and that the active percentage would be at 28.03%. That meant that within the past two grant cycle we have accomplished the goal to get back to the 28% limit and we could now regulate that with a more concrete amount in the following grant cycles. She mentioned that the study session date for the current cycle was scheduled for May 10<sup>th</sup> to provide input and comments on the funding recommendations. We would then plan to have public hearing on May 24<sup>th</sup> for the formal awards.

Ms. Mc Dowell then mentioned that the Open Space staff was scheduling meetings with the applicants throughout the month of May to touch base with them on any feedback in relation to current policies and procedures as well as initiating the topic of renewal of the tax.
