PURPOSE OF ITEM: Requesting time during the 6/21 Study Session to brief the BoCC on a recap of the 2016 General Assembly's Session, to discuss potential County-led legislation for the 2017 legislative session, and to discuss the creation of a County legislative/policy guidance document.

STAFF RECOMMENDATION: Review and discussion

BACKGROUND:

Staff has prepared a presentation to review the results of the 2016 General Assembly's Session as it pertains to legislation which the County took a position on, as well as guide a discussion related to potential County-led legislation for the 2017 General Assembly's Session. Finally, the presentation will also serve as a launching point for the possible creation of a County legislative/policy guidance document to help guide the Legislative Working Group as it navigates various legislative issues and bills during the 2017 General Assembly's Session.

This Study Session will follow up on the Study Session held on May 17, 2016 in which the Legislative Working Group presented a preliminary summary of the 2016 General Assembly's Session. That Study Session included a status of all passed and pending legislation for which the County took a position, as well as a recap of all the legislative efforts the Intergovernmental Relations Office and the Legislative Working Group undertook during the 2016 General Assembly's Session (white papers, talking points, hearing testimony, letters and resolutions, and stakeholder meetings) and set the stage for a discussion of the issues included in this Study Session (on 6/21).


