**CONTINUATION OF DECLARATION OF A LOCAL DISASTER EMERGENCY**

Pursuant to Section 24-33.5-709, Colorado Revised Statutes, and any other applicable legal authority, the Board of Directors of the South Adams County Fire Protection District No. 4 (the "District"), a quasi-municipal corporation and political subdivision of the State of Colorado, does hereby continue in effect the declaration of a local disaster emergency within the District declared and signed by District Fire Chief Kevin Vincel on March 19, 2020 due to the occurrence or imminent threat of widespread or severe damage, injury, or loss of life resulting from the presence, spread and impact of the virus that causes the disease known as coronavirus disease 2019 or COVID-19.

The purpose of the Declaration is to activate the response and recovery aspects of any and all applicable local and inter-jurisdictional disaster emergency plans and to authorize the furnishing of aid and assistance under such plans.

This Declaration shall remain in effect until such time as the Board determines and declares that it is no longer necessary.
