




PRELIMINARY HOMELESSNESS DATA RELEASED



McKinney-Vento Data is homelessness associated with the K-12 school system. In the most simplistic sense, this data does a better job than other national data sets of measuring family homelessness and doubled-up situations.




The **Point-in-Time (PIT) Count** is a snapshot of homelessness on a single night in the winter. In the most simplistic sense, this data does a better job than other national data sets of measuring single adults experiencing homelessness and unsheltered situations.

UPDATED ONEHOME PRIORITIZATION

The Metro Denver Homeless Initiative has changed their OneHome Vulnerability Index (VI-SPDAT) prioritization. Now, households that are not seeking VA housing assistance will have a greater chance of being selected if they are fleeing domestic violence, involved in the justice system, or have multiple disabilities. Adams County (AdCo) has re-opened its Emergency Rental Assistance (ERA) program for those who have suffered a financial hardship as a result of COVID-19. All sections of the application and attachments must be completed by the tenant or their case manager. There is little funding left, so encourage eligible applicants to apply as soon as possible.

Brother's Redevelopment can help tenants and landlords reach agreements outside the court system. They have many openings for mediation. Scan the QR code for more information.




SEEKING YOUTH AGES 12-25 FOR LIVED EXPERIENCE COMMITTEE



CO-RESPONSE IN UNINCORPORATED ADAMS

Did you know the Adams County Sheriff's Office (SO) launched a co-responder program this summer? The SO now has two mental health professionals contracted through WellPower (formerly Mental Health Center of Denver) to support deputies during mental health and well-being related calls.

SAFE PARKING IN COMMERCE CITY



The **Colorado Safe Parking Initiative** will be launching two safe parking sites in Commerce City for residents living in their vehicles. Previously, the closest safe parking lots for Adams County residents were on the Arapahoe County side of Aurora, Golden, and Broomfield.

Safe parking is a national movement to create safe, regulated, and hygienic spaces for people living in their vehicles. Safe parking has been shown to stabilize households and decrease crime in its respective neighborhood.

The Department of Housing and Urban Development (HUD) has released a special Notice of Funding Opportunity (NOFO) that includes \$365 million in grant funds and housing vouchers to enhance our communities' capacity to address unsheltered homelessness by connecting vulnerable individuals and families to housing, health care, and supportive services. This will fund up to \$13 million in new projects that address unsheltered homelessness across Metro Denver.

The Stout Street Foundation's recovery community provides an extremely structured, evidence-based residential setting for adults to overcome their addiction(s). They have open beds.

- The residential program is 2-3 years, from intake to graduation.
- Open to adults 18 and older committed to their recovery.
- No out-of-pocket financial commitment. All treatment fees, room, and board are included.
- In addition to treatment, residents work in our workforce development program at least 40 hours each week.
